Subject to the terms and conditions set forth herein, Wholesale Buyer (hereafter referred to as "Customer") hereby agrees to abide by the following Carbon Block Technology, Inc. (hereafter referred to as "CB Tech") policies:

1. Minimum order quantity is 25 pcs (100 pcs for international shipments) of any individual CB Tech (CBT) drinking water system and/or replacement cartridge SKU ("Products").
2. All references to prices are in US Dollars (USD).
3. Transactions must be prepaid by wire transfer or check drawn on U.S. bank. Credit cards drawn on a U.S. bank (Visa, MasterCard, American Express) may be accepted, but a 3% fee will be added to the invoice total. CB Tech will not absorb charges by banks or others relative to transfer, exchange, collection of funds, handling of paperwork, or communications concerning shipments. Such charges will be borne by Customer and added to any remittance due CB Tech. CB Tech may offer payment terms on pre-approved credit.
4. Products are sold EXW CBT's manufacturing facility (Las Vegas, Nevada). Customer is responsible for selecting shipping method and paying all necessary shipping fees and insurance for Products to reach their destination.
5. Customer agrees that Products will not be sold and/or distributed in countries other than those countries for which Customer has been expressly authorized in writing by CBT.
6. All orders will be shipped directly to Customer or to Customer's designees in authorized import countries, however, Customer acknowledges that CBT will not drop ship Products.
7. Standard lead time for all orders is 30 days unless otherwise specified by CBT at the time CBT receives Customer's purchase order (PO). However, CBT shall not be responsible for any delay or inability to deliver on a reasonably timely basis caused by labor dispute, war, governmental action, looting, vandalism, earthquake, fire, flood, or other acts of God.
8. Customer and CBT agree to comply with all Federal, State, Municipal and International laws and regulations related to manufacture, sale and distribution of Products.
9. Orders are to be submitted via fax or email in the form of a Customer's PO. The PO should include Customer's contact information, model number, quantity, price, destination, shipping instructions, and payment information.
10. CBT requires that a copy of this agreement be on file, signed by an authorized representative of Customer, in order to process and ship product.
11. Customer agrees to use his/her best efforts to promote the sale of Products in a manner favorable to both Customer and CBT.
12. All CB Tech Product sales aids, brochures, literature, etc. are the property of CBT. Any translation of literature or brochures that includes the CB Tech name or logo must be approved prior to print. All advertising for CB Tech branded Products, including internet advertising, must be approved by CBT prior to posting. The use of CB Tech and Carbon Block Technology (CBT) trademarks are limited to product manufactured by CB Tech & CBT and sold under the CB Tech CB Tech brands. Rights to use the trademarks are only granted to authorized dealers with explicit authorization in writing from MP & CBT.
13. The Minimum Advertised Price (MAP) for all CB Tech products shall be the published RETAIL price listed at [www.CarbonBlockTech.com](http://www.CarbonBlockTech.com). MAP pricing is established by CB Tech and may be adjusted by CB Tech at its sole discretion.
14. The MAP policy applies to all advertisements of CB Tech products in any and all media, including, but not limited to, flyers, posters, coupons, mailers, inserts, newspapers, magazines, catalogs, mail order catalogs, email newsletters, email solicitations, Internet or similar electronic media, television, radio, and public signage. The MAP policy is not applicable to any instore advertising that is displayed only in the store and not distributed to any customer(s).
15. The inclusion in advertising of free shipping, or free or discounted CB Tech products (whether made by CB Tech or another manufacturer) with a product covered by the MAP policy would be contrary to the policy if it has the effect of discounting the advertised price of the covered product below the MAP.
16. If pricing is displayed, any strike-through or other alteration of the MAP is prohibited.
17. MAP does not establish maximum advertised prices. All dealers and sales representatives may offer CB Tech products at any price in excess of the MAP. Internet auctions may not display or have reserved bid or other acceptable prices below the MAP price.
18. Intentional or repeated failure to abide by this policy will result in termination of dealership or sales representatives. CB Tech may not provide prior notice or issue warnings before taking any action under this policy.
19. Relationship with Customer may be immediately terminated by CB Tech if Customer's actions discredit CB Tech or violate these terms and conditions, or if Customer makes claims contrary to CB Tech Product literature or labels, or for other good cause.

20. Nothing herein contained shall make or constitute Customer as an agent or employee of CB Tech, the Customer hereto being, and to remain, totally independent of CB Tech. In any subsequent sale of CB Tech Products, Customer shall not engage in any misrepresentation or deceptive, illegal, fraudulent or unfair practices.
21. CB Tech warrants that Products will be free of defects in materials and workmanship and meet the minimum criteria for reduction of substances as certified by NSF, and this is the only warranty expressed by CB Tech. The performance of Products is dependent upon the level of contaminants being filtered; and, therefore, there is no warranty as to how it will perform on the different water supplies where it may be used or how long the filters will last.
22. CB Tech has a limited staff for customer service. End-user service of Products is Customer's responsibility. CB Tech may require Customer to purchase a spare parts kit to support Customer's customers, the contents and price of which will be determined by CB Tech based upon the quantity of Products purchased and the import country.
23. CB Tech does not refer customers to installers. CB Tech recommends that Products be installed by licensed and bonded plumbing professionals.
